  Artfx Fine Art Services Ltd is deemed to be authorised to pay all charges claimed by any previous contractor, carrier or freight forwarder and any other charges, duties or levies raised of whatsoever nature upon the goods. Artfx Fine Art Services Ltd shall have a general lien upon all goods in its possession for all monies due to it from the customer or liabilities incurred by it and for monies paid on behalf of the customer and if part of the goods shall have been delivered, despatched or sold the general lien shall apply in respect of such goods as remain in Artfx Fine Art Services Ltd possession. Artfx Fine Art Services Ltd shall be entitled to raise a warehousing charge and all other expenses defined the property of the propert during the period in which a lien on the goods is being asserted and all these Terms and Conditions shall continue to

  incurred by reason of the said sale or disposal Any surplus will be paid to the customer without interest. Artfx Fine Art Services Ltd may in its absolute discretion sell all or any part of the goods at any time once notice has been served and the prescribed time expired

## ARBITRATION

If any dispute difference or question shall at any time hereafter arise between the parties hereto or their respective If any dispute difference or question shall at any time hereafter arise between the parties hereto or their respective representatives in respect of any claim or counterclaim put forward on the part of the customer against Artfx Fine Art Services Ltd its servants or agents in connection with or arising out of this contract or any extension thereof the claim shall be referred to the arbitration of a single Arbitrator to be agreed by the parties or failing agreement to an Arbitrator being a Barrister of not less than ten (10) years call to be appointed at the request of either party by the President for the time being of the Law Society and the matter shall be dealt with according to the laws for the time being governing the resolution of disputes by arbitration in England. The costs of any such arbitration shall be in the discretion of the Arbitrator and the award of such Arbitrator shall be a condition precedent to any legal proceedings in a Court of Law in respect of any matters hereby agreed to be the subject of arbitration. The arbitration shall unless otherwise agreed be held in the town in which Artfx Fine Art Services Ltd office from which the contract was deemed to have been made is situated.
